**Planting native shrubs and trees
benefits our watersheds.**

Skamania PUD operates two water systems in the County, namely, Carson and Underwood systems. Both water systems rely on surface and ground water withdrawals to serve their respective communities. For the purposes of long-term protection of drinking water, the PUD has an interest in the preservation and enhancement of our local watersheds. As such, one method for enhancement includes the planting of native shrubs and trees. The Underwood Conservation District, a not-for-profit organization, is having an annual Native Tree and Shrub sale between March and April 2009. They can provide technical assistance to land-owners regarding tree and shrub selection and regular maintenance. Concurrently, we advise you to pay close attention to the species of the plant and the location of where it is to be planted to avoid unnecessary future management problems often associated with our power lines. Together we can help protect our watershed for both the environment and the people.

Annual Fuel Mix

In accordance with State law R.C.W. 19.29A.010, Washington State PUD's must disclose their resource fuel mix once per calendar year. Disclosure labels rely on historical data, the prior calendar year. So, for example, the 2008 label information lists your PUD's resource fuel mix for 2007. As this table shows, through BPA, Skamania PUD receives power from six primary sources to ensure that you enjoy continued reliable electrical service:

Generation Type Fuel Mix 2008

Biomass	.09%
Coal	2.57%
Hydro	85.67%
Natural Gas	1.06%
Nuclear	10.50%
Other	.11%
