Regular Meeting of the Board of Commissioners**

February 18, 2020

A regular meeting of the Board of Commissioners was called to order by President Liz Green at 9:01 a.m. at the PUD office in Carson, WA. The following persons were present: Commissioner Liz Green; Commissioner Dave McKenzie; Commissioner Dan Boyes; General Manager John Goodman, Manager of Finance & Administration Randy Payne and Administrative-Records Specialist Clerk Kelly Tennison.

**APPROVAL OF THE AGENDA:**

- Commissioner Boyes made a **motion** and Commissioner McKenzie **seconded** to approve the February 18, 2020 Agenda as amended. **Motion passed unanimously.**

- Commissioner McKenzie made a **motion** and Commissioner Boyes **seconded** to approve the February 4, 2020 Regular Meeting minutes. **Motion passed unanimously.**

- **EDA Grant Award** – Mr. Goodman presented the EDA Grant Contract. After discussion Commissioner Boyes made a **motion** and Commissioner McKenzie **seconded** to authorize Mr. Goodman to sign the EDA Grant Contract contingent on review and approval from Attorney Rick Hughes. **Motion passed unanimously.**
- **Resolution No. 2700 – Electric Construction Fund Transfer** Mr. Payne presented Resolution No. 2700 approving the Electric Construction Fund Transfer in the amount of \$40,552.97. After discussion Commissioner McKenzie made a **motion** and Commissioner Boyes **seconded** to approve Resolution No. 2700. **Motion passed unanimously.**
- **Resolution No. 2703 – Updating the District Drug Free Workplace Policy** Mr. Payne presented Resolution No. 2703 approving the Updated District Drug Free Workplace Policy. After discussion Commissioner McKenzie made a **motion** and Commissioner Boyes **seconded** to approve Resolution No. 2703 as amended. **Motion passed unanimously.**
- **Resolution No. 2704 – Rate Stabilization Fund Transfer** Mr. Payne presented Resolution No. 2704 approving the Rate Stabilization Fund Transfer in the amount of \$100,000. After discussion Commissioner McKenzie made a **motion** and Commissioner Boyes **seconded** to approve Resolution No. 2704. **Motion passed unanimously.**

- **Resolution No. 2705 – Underwood Water Construction Fund Transfer** Mr. Payne presented Resolution No. 2705 approving Underwood Water Construction Fund Transfer in the amount of \$133,258.39. After discussion Commissioner Boyes made a **motion** and Commissioner McKenzie **seconded** to approve Resolution No. 2705. **Motion passed unanimously.**
- **Broadband Feasibility Study** – Commissioner McKenzie discussed the possibility of the District to seek grant options for a feasibility study for broadband. John Goodman will proceed to look into grant opportunities.
