### INSULATION REBATE PROGRAM GUIDELINES

- All requests for rebate funds must be pre-approved. If the work is not completed within six months of approval, customer must reapply for rebate(s). There is no guarantee that funds will be available after the six-month approval or that the incentive amount will remain the same. Rebate(s) are available on a first come, first served basis and are subject to availability of funds.
- Before Installation: audit and prior approval are required. Call 1-888-883-9879 to schedule.
- All energy efficient upgrades must be installed according to Vera Water & Power specifications.
- Wall insulation: In-progress photographs required before, during & after insulation installation. The pictures must be included with the final paperwork submission.
- After Installation: Submit the final paperwork to [rebates@esgrouplc.com](mailto:rebates@esgrouplc.com), mail or fax to 503-344-6942. Your project will be added to the final inspection list. A final inspection is required to process the rebate. After you have submitted the final paperwork, you can call 1-888-883-9879 to verify that you will be on the schedule.

**REBATE APPLICATION DOCUMENTS**

**Rebate(s) will be paid when Skamania PUD has received the following required documents:**

- Contractor installed: copies of **contractor final invoice(s)** showing R-value of existing insulation, R-value of final insulation and square footage of added insulation. The date of the installation and invoice date must be on or after October 1,2019.
- Self-installed: copies of **purchase receipt(s)** showing R-value of existing insulation, R-value of final insulation and square footage of added insulation. The date of the installation and invoice date must be on or after October 1,2019.
- Completed **Residential Site Built Insulation Rebate Application** form.

**A final inspection must be completed before the rebate is processed.

# RESIDENTIAL INSULATION REBATE PROGRAM

## Steps to Participation

### 1. PRE-INSTALLATION AUDIT

A Skamania field representative will perform a *one-time* audit to determine the existing condition of your home before your insulation is upgraded. Audit results are kept on file for future reference.

- Call 1-888-883-9879 to request a no-cost audit. Audits are scheduled the middle of each month. You will be contacted 2 to 3 days prior to the audit with your scheduled date and time. You do need to be home during the audit to provide access to all insulation upgrade areas, including crawl space(s) and attic.

**Site Built Home Audits May Include:**     Floor     Attic     Wall\*

*\*Wall insulation installed in an open or closed cavity or any measure not available for post-insulation inspection requires photos of before, during and after upgrade(s) to be included with the rebate application final documents.*

- Two to three weeks after the audit, you will receive a follow-up letter to confirm that rebate funds have been reserved for your project for six months. Projects not completed within the six-month time period must re-apply for rebate funds.

### 2. INSULATION UPGRADE

- After the audit, you can begin to upgrade the insulation in your home or hire a contractor to do the work.

### 3. REQUEST YOUR REBATE

**ALL DOCUMENTS ARE REQUIRED TO PROCESS YOUR REBATE(S)!** After the project is complete, please forward all the final paperwork to [rebates@esgroupllc.com](mailto:rebates@esgroupllc.com), mail to the address on the form or fax to 503-344-6942.

- Contractor final invoice(s), or your receipt(s) if self-installed, showing the beginning and ending R-value and the total square footage of upgraded insulation. The installation and invoice must be dated on or after October 1, 2019.
- Completed Residential Site Built Insulation Rebate Application.
- Wall insulation photos required of insulation before, during & after installation. Please submit with the final paperwork.

### 4. POST-INSTALLATION INSPECTION

- Once the final paperwork has been received at [rebates@esgroupllc.com](mailto:rebates@esgroupllc.com), the project will be added to the inspection list. After the final paperwork has been submitted, you can call 1-888-883-9879 to make sure that the project has been added to the no-cost final inspection list. You will be contacted 2 to 3 days prior to the inspection with your scheduled date and time. You do need to be home during the inspection to provide access to all insulation upgrade areas, including crawl space(s) and attic.

### 5. RECEIVE YOUR REBATE

You can expect to receive your rebate 8 to 10 weeks after the final inspection and receipt of all required documentation.

**All work must meet Bonneville Power Administration (BPA) and Skamania PUD program and installation requirements.**
