As a condition of payment, Contractor agrees to send its final invoice to Skamania PUD within 90 days of acceptance of their work by the PUD unless otherwise is agreed to in writing. To remain on the roster, a new application must be filed every three years. Applications expire three years from the date of receipt. Applicants are responsible for re-applying before expiration of their application to insure they are not removed from the roster.
